



Gorgas and Bruno Libraries Make Changes To Accommodate Students' Needs

Gorgas' First Floor Undergoes Makeover

After months of planning and renovating, the first floor of Gorgas Library opened recently with a brand new state-of-the-art look. Now known as the Gorgas Library Learning Commons, the area has the ability to seat 459 patrons. This total includes 405 seats for study tables and computers and 54 upholstered seats. Before the refurbishment, the seating capacity was 255.

Gone are old stacks of reference books, dark paint and lighting. New paint, carpet, desks, chairs, and lighting have created a bright, clean, contemporary area for students to study. Also included in the project were the addition of floor boxes to accommodate the ever-growing need for electrical and data outlets.

Dr. Mildred L. Jackson, associate dean for collections, said, "The University Libraries recognized the need for additional space for students to study - together and individually - and a demand for more computer work stations."

Shepley Bulfinch, an architectural firm with 135 years' experience in designing libraries, reviewed the first floor and made recommendations on how the space could be

used to provide the optimum level of service to our library users.

They also suggested furnishings that would provide comfortable, efficient, and flexible work spaces that would appeal to students.

Students, faculty, and staff took an active role in selecting the furniture. Hugh Kilpatrick, university architect, and Garnette Hatchett, project manager, worked with Poole and Co. Architects to develop and execute the plan which transformed the space into a more inviting and functional place.

Susanna Johnson, associate director of University of Alabama Furnishings and Design and Kacie Obradovich, interior designer, designed a space that is fresh, modern and appealing to library users of all ages.

"The rise in enrollment, along with the increased use of the library, contributed to the need to renovate the area," stated Dr.

Louis A. Pitschmann, dean of libraries. "Our goal was to create an area where students, faculty and staff could come together to

work, do research and receive assistance from our librarians."

Other changes include a new tutorial area for The Center for Teaching and Learning in the former copy center and an additional study room next to Java City.

Bruno Business Library's New Laptop Study Area

The Angelo Bruno Business Library now has a special area on the first floor designed specifically to support laptop use. In prime space opening onto the Jones Reference Services Area, two types of seating have been added to accommodate the ever-increasing use of laptop computers in the Bruno Library.

In the corner are three clusters of upholstered lounge-type chairs outfitted with tablet arms giving students a surface for their laptop computer. Extra electrical outlets are available in the floor between each pair of chairs for easy access. The chairs are easily moved, enabling students to arrange the chairs to collaborate or to work independently.

Adjacent to the lounge furnishings are modular-style tables with comfortable high-tech task chairs. The tables, which seat either four or six persons, have numerous electrical outlets above the tabletop. Students can easily plug in their laptops, cell phones, and other electronic devices while they are studying.

The newly designed area was made possible by generous support from the Ann and Angelo Bruno Foundation and from Mrs. Janet Faucett. "The laptop-friendly design is proving extremely popular with our students," stated Lee Pike, head of Bruno Library.

Angelo Bruno Business Library Hosts North American Conference

An important library conference was held on the campus of The University of Alabama during 2009. The Academic Business Library Directors (ABLD) held its annual conference and business meeting in Tuscaloosa. Programs and events took place at Bryant Conference Center, the Angelo Bruno Business Library, the Culverhouse College of Commerce's Alston Hall, and at North River Yacht Club.

The Academic Business Library Directors is a highly selective membership organization comprising the directors of business libraries at leading business schools in the United States and Canada. The Angelo Bruno Business Library is a charter member of the group, which was organized in the 1980s. The University of Alabama is the only Deep South public university holding membership in ABLD. Membership is limited to fifty institutions.

The top ranked business schools, such as Harvard Business School, Wharton School at the University of Pennsylvania, Stanford University, and other prestigious private schools form the core of the membership. Leading business schools at a number of respected public universities complete the membership. In addition to The University of Alabama, public universities represented include UCLA,

Pennsylvania State University, University of Iowa, University of Wisconsin, and University of Southern California, among others. Examples of Canadian schools in the group are University of British Columbia, University of Toronto, and McGill University.

ABLD provides a forum for directors of academic business libraries in North America to collaborate and to discuss latest developments in business information and library research services, technology, and knowledge management and distribution. Other interests include the opportunity to influence development of new products and services for the academic business library market and to influence relations with corporate vendors

of databases and other electronic resources.

Lead planners for the 2009 conference program at Alabama were: Lee Pike, The University of Alabama; Jan Wallace, University of British Columbia; and Corey Seeman, University of Michigan. Planning support came from fellow ABLD board members: Millicent Gaskell, MIT; Hope Tillman, Babson College; and Kathy Long, Stanford University.

“The 2009 Academic Business Library Directors Conference was a huge success by all accounts,” reports Lee Pike, professor and head of Bruno Business Library. “Most conference attendees had

UA Student, Katy Montalto Recording in Sanford Media Resource and Design Center

Graduation is approaching and Katy Montalto is thinking about her future. Her dreams include writing country music songs, working on a country music television show or maybe becoming a country singer and songwriter. We hope the University Libraries had a small role to play in starting her career.

Last fall, Montalto, a senior double-majoring in musical theater and telecommunication and film, entered her self-made video in CMT.com’s fourth Music City Madness competition for unsigned artists. She had used the Sanford Media Resource and Design Center (SMC) for past class projects and knew where to go to make her video. “It was awesome to have it as a resource for something like this as well,” stated Montalto. “Everyone is always so helpful.”

First, Montalto recorded her original song, “Driving On,” in the media center. Next, with camera equipment borrowed from the SMC, Daniel Lincoln shot footage of Montalto in and around Northport. With skills learned in her communication classes, Montalto returned to the SMC to edit her raw footage. Finally, she sent her video to CMT.com and waited.

Several hundred videos were entered in the contest before judges narrowed the competition

to 64. Montalto made the cut. Similar to basketball tournament brackets, contestants were placed in single-elimination brackets with fans voting each week to determine who advanced. Week after week, friends, family, and fans continued to vote moving her up in the competition. When the contest ended, Montalto had made it to the final eight.

The Trussville native gained valuable knowledge in entering her first contest. She said the experience helped build her confidence. Montalto continues to work in local venues and write country songs.

The Sanford Media Center, a multimedia lab for students, is located on the second floor in the






