## Message from the Dean

With the arrival of 2019, it is incredible to imagine everything we have accomplished in The University of Alabama Libraries during 2018. We are over halfway through our strategic planning process and are well on our way to meet the aggressive goals and objectives we have planned for the remaining two years. Foremost for the campus, The University of Alabama has reached major milestones in increasing research revenues and outputs, and the University Libraries has been a campus-wide partner in these achievements. We added several important research collections this year, had 1.4 million visitors to our physical libraries, and our databases were searched almost 7 million times by UA students and faculty! Several new and impressive items for Special Collections were acquired, including diaries and

manuscripts from the Civil War and reconstruction eras, historical maps and photographic collections of Southern history, and the senatorial papers of Jeff Sessions and Luther Strange. In addition to the exhibits and displays of rare historical items we make available throughout the year, the University Libraries Special Collections serves as the flagship for documenting the State of Alabama's cultural and historical heritage, and we are delighted to be a partner in the celebration of the State of Alabama's Bicentennial this year.

In our commitment to outreach to the State of Alabama, hundreds of events took place in our libraries. Of prominence, the University Libraries Alabama Center for the Book, along with the Alabama Writers' Forum, hosted the Alabama Writers Hall of Fame 2018, inducting eight distinguished Alabama authors including, Winston Groom, Gay Talese, Charles Gaines, Shirley Ann Grau, William Bradford Huie, Wayne Greenhaw, James Haskins, and Joseph Glover Baldwin. We were also excited to present lecture series by the award-winning Civil War historians, Dr. Thavolia Glymph and Dr. Christopher Phillips. Additionally, serving as the oldest research library government documents regional repository in the United States, The University of Libraries hosted the U.S. Government Publishing Office and administrators of state depositories on campus.

As a leader in library instruction and digital research in the Southeastern Conference, librarians taught research workshops to over 19,000 UA students! Equally, the Library Instruction Program initiated a university-wide assessment of students in English composition courses in order to continuously improve upon the teaching and learning missions of UA. We hosted another successful Digitorium conference on teaching digital humanities for the international research community, and our 3D technologies instruction has been tremendously successful with the advent of the 3D Tech Fair for The University of Alabama community to explore 3D printing and scanning, structure sensors, 3D stereoscopic vision, and virtual reality. In order to support the physical infrastructure needs of the teaching and research mission of UA, the University Libraries also oversaw several physical infrastructure projects, including renovations to Amelia Gayle Gorgas Library's 2nd floor and 4th floor mezzanine, along with computer labs and new Whisper Sound Studios in the Music Library.

As we close out 2018, we want to extend our heartfelt thanks to the University Libraries Leadership Board, to our donors, and to our colleagues across the State of Alabama and throughout the United States. We are accomplishing great things at The University of Alabama Libraries, and we are able to do these things through your continued support.





## **NEW SERVICE**

#### Free Electronic Resources: Pilot Program Addresses Cost of Textbooks

University Libraries and the SUPE Store teamed up this year to address the problem of rising textbook costs. The SUPE Store worked with University Libraries to tag books at the store indicating the books were available in the library's collection either in print or online. Books were available for two-hour reserves and could be checked out more than once; there was not a time limit on accessing electronic textbooks. This project helped students keep college costs lower.





## **NEW SPACES**

University Libraries spaces are continually evolving to suit the needs of users.

Amelia Gayle Gorgas Library first opened in 1940 and was enlarged by adding stories and expanding in the rear in the 1960s. The footprint of the building remains the same, yet our student body continues to grow. In 2017, students, faculty, and staff were asked to complete surveys and were invited to attend focus group meetings. We wanted to know what our patrons wanted in the building.

## OUTREACH



#### **INNOVATIVE INSTRUCTION**

Throughout the year, librarians collaborate with professors across the disciplines to assist with classroom instruction and research projects. Instruction–via face-to-face sessions with a librarian or online tutorials–is designed to help students achieve a solid foundation of research skills required to complete assignments, thus achieving a successful academic experience.

Librarians from Special Collections partner with faculty to bring the research process alive by sharing rare and unique materials. By seeing and touching photographs, letters, manuscripts, and other one-of-a-kind objects, students learn and absorb information first hand.



#### **GREAT CAMPUS WRITE-IN**

Each fall and spring, University Libraries teams up with the Campus Writing Center to sponsor writing workshops for our undergraduate and graduate students. Writing tutors and librarians provide research support and assist students in the writing process.



#### INSTITUTIONAL REPOSITORY WORKSHOP

The Institutional Repository is a platform for collecting, preserving, and distributing the scholarly, research, and creative works produced by The University of Alabama community. Faculty received information about the benefits and advantages the IR can provide researchers in order to widen the distribution and impact of their scholarship, obtain more citations and attributions, and invision how the IR can assist in navigating publishers copyright policies.



#### PUBLISHING WORKSHOP

University Libraries and the Graduate Student Association sponsored the second annual publishing workshop for all graduate students. Topics ranged from personal experiences in publishing journal articles and books; popular literature research and management tools; tips for selecting a publisher and preparing articles for submission; and what reviewers and editors are looking for during the submission and revision processes.



#### LIBRARY EXPO

University Libraries and library vendors teamed up to sponsor the second annual Library Expo in the Ferguson Student Center Commons. The Expo provided, an opportunity for University Libraries faculty and staff to reach the campus community and to explain about our resources, services, and specific researchrelated products. Vendor representatives were on hand to explain their products offered by University Libraries and how students could use these products for class assignments and projects, and for fun, too.



#### **3D TECH FAIR**

Students and faculty were invited to Rodgers Library for Science and Engineering to learn about the different technology offered in the library, including Oculus Rift, structure sensor, 3D stereoscopic vision, and 3D printing and scanning.



#### LETTERS ABOUT LITERATURE

The Alabama Center for the Book, housed in University Libraries, sponsors the Letters About Literature, a national reading and writing contest for students in grades four through 12. Students are asked to read a book, poem, or play and write a reflective letter to the author about how the author's work changed them or their view of the world. The award ceremony, held in the Amelia Gayle Gorgas Library in April, was attended by state finalists, and their families and teachers. The number of entries from Alabama, 479, more than doubled from last year. This is the eighth year the University Libraries has hosted the contest and award ceremony.



#### ALABAMA WRITERS HALL OF FAME 2018

The Alabama Writers Hall of Fame inducted eight distinguished Alabama authors including Winston Groom, Gay Talese, Charles Gaines, Shirley Ann Grau, William Bradford Huie, Wayne Greenhaw, James Haskins, and Joseph Glover Baldwin. Groom, Talese, and Huie are graduates of The University of Alabama. The Alabama Writers Hall of Fame was founded in 2015 through a partnership between The Alabama Center for the Book, University Libraries, and the Alabama Writers' Forum.

## **SPECIAL COLLECTIONS**

The primary function of a special collections library is to promote scholarship by providing researchers access to items of enduring historical value while ensuring their longevity. Our collections document exploration and settlement of the area that became Alabama; the cultural, political, social, and economic history of Alabama and the South; the Civil War and Reconstruction; slavery and its abolition; the Civil Rights Movement; and specific programmatic research on campus.

*We bring together such rare and unique materials as books, papers, letters, diaries, maps, photographs, music, and artifacts.* 

#### FY 2018 PROJECTS

- Initiated the migration of digital content to a new digital assets management system
- Collaborated with UA divisions and departments to celebrate the 125th anniversary of women on campus
- Launched two LGBTQ websites: Empowering Voices and the Alabama Forum
- Received a grant for \$324,774 from the National Endowment for the Humanities National Digital Newspaper Program to digitize Alabama's historic newspapers on microfilm
- Processed more than 155 linear feet of manuscript, photographic, and other archival materials
- Digitized 32,206 manuscript and visual materials on a new state-of-the-art large format scanner, including maps, manuscripts, letters, diaries, photographs, and business and genealogical records



## **EVENTS**





#### **University Libraries Ice Cream Social**

Each fall, University Libraries hosts an Ice Cream Social on the Quad. The event is a fun way for students to meet our faculty and staff and to learn more about our services and resources.



#### **Faculty Reception**

For the past two years, University Libraries has hosted a reception for newly tenured and promoted faculty from across the campus. The reception offers an opportunity for the faculty to interact with each other and a chance for University Libraries to congratulate our colleagues on this significant achievement.

#### Society of Alabama Archivists

University Libraries Special Collections hosted the Society of Alabama Archivists annual meeting. Founded in 1977, the society's members include archivists from the Alabama Department of



Archives and History, state municipalities and counties, colleges and universities, military installations, and special topic archives.



#### **Regional Federal Depository Library Program Meeting**

The University of Alabama Libraries is the oldest academic research library in the United States, serving as a regional depository for federal documents since 1860. The Boston Public Library is the oldest public regional depository, serving since 1859. The Depository Library Act of 1962 created the presentday Federal Depository Library Program (FDLP) to help better organize depository collections and services, and is administered



by the Government Publishing Office (GPO). University Libraries hosted a regional meeting of administrators of state depositories to discuss ongoing issues relevant to providing depository services. Kathy Bayer, outreach librarian with the GPO, provided information about changes in the law that establishes and governs the FDLP, and shared information about general collections maintenance and community outreach.

#### **Guest Lectures**

University Libraries invited the UA community and the general public to hear two guest speakers in 2018: Dr. Thavolia Glymph from Duke University and Dr. Christopher Phillips, University of Cincinnati.

Glymph's talk explored the Civil War refugee camp and focused on the ways in which notions of diseased and sexualized black female bodies influenced the administration and the resistance of refugees to policies that placed them outside the boundaries of legal and civil rights.

Phillips' lecture, also about the Civil War, revealed the complex history of the western border states as they struggled with questions of nationalism, racial politics, secession, neutrality, and loyalty.

#### **Digitorium 2018**

Inspired by working with scholars and students, Digitorium, was launched four years ago by the Alabama Digital Humanities Center, located in the Amelia Gayle Gorgas Library, to bring students, faculty, and scholars together to discuss the wide range of digital methods which are used and shared by researchers, graduate students, and practitioners from the humanities and the social sciences.

A variety of topics and workshops were presented by national and international speakers. The threeday conference was sponsored by The University of Alabama's Hudson Strode Program, Department of Religious Studies, Department of History, Summersell Center for the Study of the South, and University Libraries.

## **IN MEMORIAM**

#### DORA HENLEY GOING - 1916-2016

A native of West Point, Mississippi, Dr. Dora Henley Going began her teaching career as an instructor of microbiology at The University of Alabama in 1947. After marrying Dr. Allen Going, professor of history at the University, in 1954, the couple moved to Houston, Texas, where Dr. Dora Going was professor of microbiology in the Dental School of the University of Texas. The Goings retired and returned to Tuscaloosa in 1980. Dr. Going volunteered for many non-profit organizations and served on the University Libraries Leadership Board. Through her estate plans, the Dora H. and Allen J. Going Endowed Library Support Fund was established in 2018 for the acquisition and preservation of books and other historical material pertaining to the study of history.

#### LOIS MARIE ROBERTSON - 1930-2017

After graduating from The University of Alabama in 1952, Lois Marie Robertson went to work as a librarian at Redstone Arsenal in Huntsville until her retirement in 1986. She was a member of the Alabama Society of the Daughters of the American Revolution, a member of Colonial Dames and a member of the United States Daughters of 1812. In 2009, Robertson joined the University Libraries Leadership Board and served until her death in 2017. In 2018, The Lois Robertson Endowed Support Fund was established through her estate gift to preserve materials in the University Libraries Special Collections.

#### **JOHN H. JOSEY** - 1926-2017

In 1992, John H. Josey responded to a request from the National Steering Committee of the Campaign for Alabama to serve as chair of the University Libraries steering committee, marking the first organized effort to raise funds for University Libraries. Josey led the committee for eight years traveling throughout the state. In 1993, he and his wife, Carolyn, supported this unprecedented campaign with a commitment of \$1,000,000 to University Libraries. In gratitude, the Rotunda Plaza in front of Amelia Gayle Gorgas Library was dedicated in their honor. Josey went on to become a founding member of the University Libraries Leadership Board and a generous supporter of many University Libraries projects. Josey graduated from The University of Alabama in 1950 and was actively involved with The University of Alabama including the Presidents Cabinet and Honors College Board.

#### LINDA FRANCES SPARKS - 1936-2018

Born in Lineville, Linda Frances Sparks graduated from The University of Alabama in 1958, and went on to earn a master's degree in library science from Louisiana State University. Sparks returned to work at University Libraries, but was soon hired by the University of Florida, serving 40 years. She was awarded associate librarian emerita upon her retirement. Sparks was a member of The University of Alabama Denny Society and left a planned gift through her estate to University Libraries.



University Libraries raised \$23,393 in gifts from 58 supporters in the inaugural Bama Blitz thanks to a matching gift from the University Libraries Leadership Board.

Funds raised by University Libraries were designated to complete the *Corolla* Digitization Project, an ongoing project to digitize all yearbooks.

Bama Blitz, which began at noon, April 11 and ended at 8:31 p.m., April 12, was powered by a robust crowdfunding and social media strategy that showcased fundraising "challenges" between colleges and schools and charted gifts on a real-time leaderboard.

- Training and technology that support innovation and entrepreneurship.


